Openine

The General Assembly (GA) was opened at 16:30 CET.

At this time, 18 member organisations were present. As no quorum was represented at the opening of the GA, it was – as in previous GAs – decided that no formal decisions shall be made within the first 30 Minutes, as any quorum at that time will be eligible in accordance with the statutes (§9 (11)).

The GA was chaired by the General Secretary together with the Liaison Coordinator; they presented the Agenda (see Annex 1) and no motions to the agenda were requested by the present members.

Two motions to the agenda were proposed by the General Secretary, which were not included in the initial invitation to the GA due to a mistake:

- Election of 2nd external auditor (in-person vote)
- Motion to amend the article of the association (waiving of fees)

The General Secretary has informed the present member that the GA is formally covering the periods 2021 and 2022. (In 2021, the planned GA alongside the PHERECLOS Final Conference was not held due to a minor number of members being present at the very end of the Conference. Eventually, the GA was opened and the present members decided to postpone until the next opportunity, before the GA was closed immediately, followed by informal discussion about various issues.

Activities of past period - reports from the Presidency and Liaison Coordinator

For details see Handout of the GA (see Annex 1).

While presenting activities of the past period, Liaison Coordinator has pointed out that members should use the EUCU.NET logo more intensively for the promotion of the network, eg. on members' websites.

While reporting about several study visits, it was pointed out that members can use ERASMUS as co-funding for better opportunities to visit each other, eg. for study visits or job shadowing.

Members were encouraged to "advertise" EUCU.NET at all manifold opportunities, like for examples conferences. The PHERECLOS Final Conference included some EUCU.NET partners, either as partners or mentoring partners. Further information and final reports are available on the PHERECLOS website (special recommendation: the Implementation Guide) and parts of the material will be made available at the EUCU.NET website as well.

General Secretary had pointed out the relevance of mentioning EUCU.NET and the achievements of CUs as a model of science engagement in funding propels, also for raising awareness among the



experts who are evaluating the proposals, even when proposals are not successful. The EUCU.NET secretariat could share text elements as building blocks for proposals – for example for the dissemination part or for the methods part – which outline the relevance of the CU approach and the network. Interested parties shall contact Liaison Coordinator or General Secretary.

Liaison Coordinator has pointed out the relevance of creating content and enhancing visibility on social media; members were invited to send content, to link or re-share content and to use the EUCU.NET hashtag. Members were invited to have a stronger role in social media and to take over part of the tasks and activities. Interested parties shall contact Liaison Coordinator or General Secretary.

Members were encouraged to give feedback on how EUCU.NET products can be used or how they are being used or how to update them.

FutureSIM was presented as a successful submission, which includes EUCU.NET members as possible dissemination partners. An in-person meeting will be held in Vienna (probably in June 2024), that can be used as a networking event also.

It was underlined that members should use the network for the dissemination of their own projects (of various kinds and topics) as well.

It was announced that the re-election of the presidency is due in 2024; official invitations will be sent in due time.

Financial issues, accounting and status of membership - report from the general Secretary

For details see Handout of the GA (Annex 1).

The General Secretary has explained that EUCU.NET has a stable financial position, this is mostly due to fact that little costs occur - mostly used for domain fees and bank accounts charges. However, an increasing number of members fails to pay fees in time – reminders will be sent out together with the 2023 membership fee invoices before the end of the year.

The General Secretary has called a GA decision from 2020 to mind that Vienna University Children's Office (KUW) as the EUCU-NET Secretariat is entitled to request a compensation up to EUR 5.000 per year to cover unremunerated efforts. So far, Vienna University Children's Office had never claimed such due to the possibility to cover efforts from other (EU) funded activities, but it may happen in the future if funding gaps occur. Karoline lber as the Executive Director of KUW has made a remark that KUW is the only remaining member of membership level "big" – so there will be a necessity to claim some funds in return.

Audit reports for both periods of 2021 and 2022 were presented; audit reports state the accuracy of all financial conduct in full compliance with legal requirements and the statues of the network.



Exoneration of the board

Exoneration of the board by show of hands with unanimity (18 consent, no refusal, no abstention).

Election of 2nd external auditor

Appointment of Ms Susi Spelitz as the 2nd external auditor was confirmed by show of hands with unanimity (18 consent, no refusal, no abstention).

Ms Susi Spelitz was introduced as a qualified accountant and controlling expert; she has worked for KUW for several years and is now working as a senior specialist in the financial sector. Ms Susi Spelitz was appointed as the 2nd external auditor by interim Board decision in 2021, after Ms Anna Schnelzer had resigned.

Motion to amend the Articles of the Association

Due to occasional request by members, a decision was pending that member shall be able to omit payment of membership fees for qualified reason, eg. lack of funding, suspension of CU activities or similar without the need to fully guit their membership.

It was agreed by show of hands with unanimity (18 consent, no refusal, no abstention) that the statues shall be amended as follows:

"Be decision of the Executive Board, a member can be exempted from membership fee obligation by written request for justified reason for one period once within five consecutive periods." (§7 (4) to be added)

KUW will take the responsibility to inform the competent legal authorities in Austria about the amendment of the Articles of the Association and seek approval.

Future activities - outlook and decisions

No future activities were discussed during the GA, as room for this was left during the Open Space on the following day (7th November 2023, see documentation of the networking meeting on https://eucu.net/project/vienna-open-space/)

Closure of the general Assembly

The GA was closed at 17:30 CET as scheduled.





In the following funding requests, EUCU.NET as a membership organisation and network and/or particular member of EUCU.NET were included and mentioned as an experienced and reliable party, mostly relating to piloting, disseminating, mentoring and advocating for the concerns of early STEAM engagement, inclusive and responsive pedagogies, listening to young people, science capital, educational pathways and social inclusion.

Calls for proposal are extremely competitive in Horizon Europe and meanwhile also in Erasmus+. In consequence, only a little ratio of submitted proposals can be successful, despite the generally positive evaluation results of the below mentioned proposals.

In any case, participation in such proposal is definitely supportive for positioning Children's Universities as a profound and reliable approach in community engagement and outreach in the above-mentioned contexts – and make it known to a wider range of experienced evaluators as acknowledged experts in these fields.

• PROSEED - Promoting Soft-Skills in Early Childhood Education through Dialogue

Call: ERASMUS-EDU-2022-CBHE-STRAND-2

Topic: Capacity building in the field of higher education Action: ERASMUS-LS ERASMUS Lump Sum Grants

Coordinator: The Research Authority, Beit Berl Academic College, Israel

The project PROSEED directly supports the vision of the future kindergarten model recently announced by the MoE where Early Childhood Education (ECE) programs would be designed to promote children' participation in playing environments, construction of their physical environment and by using design processes for building learning environments. According to the PROSEED model, kindergartens in the future will be based on the ability of children and kindergarten teams to initiate, lead, study, research and create their own knowledge. This will be achieved through a constant interaction amongst all involved players: children, teaching teams, parents and policymakers. The culmination of this initiative and main exploitation strategy will be reflected in the establishment of a first children's university in Israel, which will constitute undoubtedly a leap forward in early childhood education in the country.

Using mediation to tackle the growing problem of conflict and violence in schools is a very new and innovative approach. It requires that schools develop multi-sectoral strategies for dealing with problems. It includes crucial debates about children's rights and about the role of the youth workers and responsibilities of different stakeholders - schools, teachers, parents, society. This project focuses in particular on teenagers and the relationship triangle between institutions - youth - families. The achieving of these objectives is not only a task for public authorities and decision makers, but the responsibility shall be shared between the society as a whole, including all the stakeholders - families, media, educators, businesses and community. Therefore, within this project, special efforts will be dedicated to raising awareness and involving different stakeholders in activities designed to meet the overall project objectives. Formal, non-formal and informal education and access to lifelong learning not only provide knowledge, skills and competences, but should also help learners to develop ethical and civic values and become active, responsible, openminded members of society.

TOGETHER involves EU and global leaders in Open Schooling (OS) to co-design and implement an ambitious set of action along three main axes: a child/family-centred vision of innovation in education, based on listening to, participation of, and co-creation with young people and their families; establishing and solidifying local networks among schools, research organisations, tertiary education, and other social actors from the science, culture, creative and business sectors; developing innovative Citizen Science (CS) approaches to provide ownership and sense-making in science education. The TOGETHER consortium will develop a lifelong and life-wid learning framework for science education based on OS aimed at supporting schools, formal and non-formal education providers, families, universities, research institutes, companies and SMEs to integrate OS in their practices and institutional culture. This will be achieved by positioning the expectations, needs and concerns of individuals, in particular of youth and their families, at the centre of learning. The TOGETHER roadmap will include three complementary components: stocktaking from previously funded OS projects, with a particular focus on CS as an innovative component in OS; stakeholder engagement and community building tools. TOGETHER proposes to establish local OS incubators, composed by a partnership between a project partner, with experience in OS, and a partner of strategic relevance for the establishment, consolidation and expansion of the lifelong and life-wid learning strategy. TOGETHER will contribute to the increase of highly qualified scientists, researchers, innovators, capable of linking with the educational system to deal with the complex and dynamic science-related challenges of our contemporary society; to enhance the acquisition of knowledge and skills needed for sustained participation in working life, family life and all levels of community life in a continuous way thus fostering active citizenship.

PHERECLOS builds upon the theory of science capital and the experience that Children's Universities (CUs) have made in the Third Mission of universities. With their engagement with children and young people, they became intermediaries between various actors in the educational and social landscape. As translators of the concerns, messages and knowledge of other parties (incl. business and industry, the state, civic society organizations etc.) they help to dismantle institutional boundaries of universities towards a wider society. The project will establish 6 "Local Education Clusters" (LECs), which bring together schools and further relevant actors in the education ecosystem of a particular pilot region, supported by a peer mentoring programme. The LECs will be incubators for enabling a dialogue between various parties and help to set up joint activities in (formal and non-formal) education, which help to develop collaborative learning environments as experimental testbeds for schools. The regional effectiveness and impact will be monitored by academic transfer and implementation research and lead to the development of implementation guidelines and policy briefs to enhance the sustainability of the overall approach. PHERECLOS promotes the territorial dimension of local education clusters in all their manifold facets and their catalyzing role relating to access to STEAM and higher education, critical thinking and informed decision making in a wider societal context – including competitiveness and sustainable growth.

Environment and climate action are the most urgent priorities of our time. The European Green Deal confirms the EU's commitment to tackle climate and environment-related challenges. The UN agenda 2030 emphasises the need to integrate social, environmental and economic aspects to accomplish this goal. For the Green Deal and the UN Agenda 2030 to succeed, involvement and engagement of the public is of utmost importance. Schools contribute significantly to engage pupils, parents and the wider community in a successful sustainable transition. Thus, SDGs are increasingly being integrated into European school curricula. However, often this integration lacks deep pedagogical embeddings and is experienced as a top-down approach. To address pupils in ways they find meaningful, interdisciplinary tools and inquiry-based learning methods linked to real-life problems and decisions of pupils that foster the understanding of complex and interconnected challenges in Europe and the world are needed. Global Citizenship Education (GCE) as a pedagogical approach has the potential to provide a proper methodological tool box for this aim.



We address this context by designing an open-access simulation-based learning program for cross-curricular education on sustainable development. It will stimulate citizenship and digital competencies in school for an age group 14-19 with a focus on social inclusion
